Turney and Munson Buel of said Town of Windham my sole executors of this my Last Will and Testament, and it is my will that all my real Estate consisting of land and buildings be sold to Amos Peck of the Town of Wallingford in the County of New Haven and State of Connecticut provided he will pay to my Executors aforesaid the sum of Seven hundred dollars good and lawful money of the United States of America and in case the said Peck shall not choose to by the said property and pay the sum aforesaid for the same then it is my Will that my executors dispose of the same to the best advantage they can for money out of which together with all my personal property, sums of money which are due or may become due it is my Will that my Executors pay all the debts I am justly oweing, pay my funeral charges and erect at my grave and the graves of my wife and child decent sets of grave stones. And out of the remainder I do give and bequeath to the above said Robert M. Turney the sum of one hundred & seventy five dollars. I also do give to John Tuttle of the Town aroresaid the sum of Fifty dellars I also give to my uncle Levi Parker the sum of two hundred dollars. I also do give Lawley Andrews wife of Ichabod Andrews the sum of fifty dollars I also do give to Samuel Chichester, Son of Rebecca Fowler wife

of Simeon Fowler the sum of Fifty dollars. I also do give to my half sister Hannah Peck the sum of twenty five dollars. I also do give to Simeon Fowler my mare saddle and bridle of the value of Sixty dollars--and the remainder of my property of whatsoever kind or nature I do give to be appropriated towarde finishing the meeting house on the mountain near Abraham Camp Esqs dwelling house in said Town of Windham -- And I do hereby revoke all former wills by me made--In witness whereof I have hereunto set my hand and seal the 29th day of February in the year of our Lord 1808 Signed Sealed Published and declared by the above named Munson Parker to be his last Will and Testament in the presence Munson Parker (L.S.) of us who have hereunto subscribed our names as witnesses in the presence of the Testator Isaac Buel, Theo.
