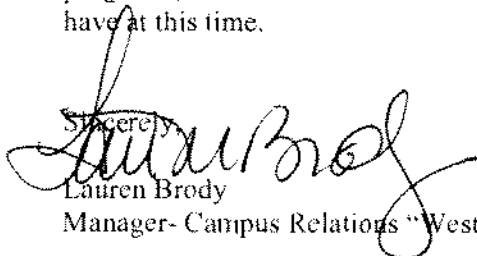


Dear Cyndi,

Section 1

Introduction

Mentoring Definitions

Mentee - The protégé or lesser experienced employee who desires to be coached by a more experienced member of the organization.

Mentor - The individual selected to coach and develop a lesser experienced member of the organization.

Mentoring - A flexible concept that should reflect the unique culture and objectives of the organization.

Coaching vs. Mentoring

Coaching	Mentoring
▪ Something which managers must do for all their staff, as required part of job ▪ Takes place within confines of the formal line manager - employee relationship ▪ Is job-focused: focuses on developing the individual within their current job ▪ Interest is functional - arising out of the need to ensure that the individual can perform the tasks required of them to the best of their ability ▪ Relationship tends to be initiated and driven by the individual's manager ▪ Relationship is finite - ends as individuals move on to work in other jobs under other line managers	▪ Formally, the mentee's manager is not the mentor ▪ Takes place outside line manager relationship ▪ Is focused on professional development that may be outside of mentee's area of work ▪ Interest of the mentor is personal in that the focus is on the mentee to provide support both professionally and personally ▪ Relationship may be initiated by mentor and/or matched by the organization ▪ Relationship crosses job boundaries ▪ Informally, managers may choose to do for specific, selected employees

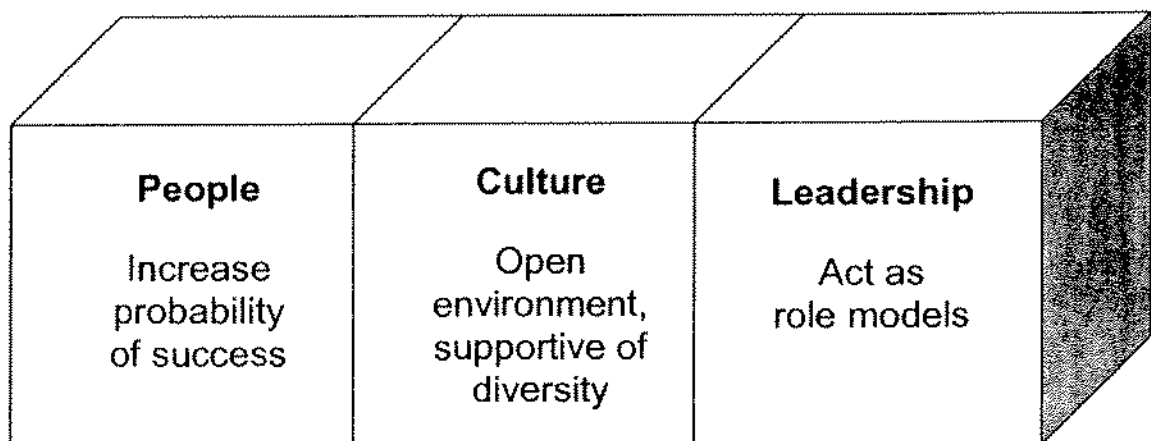
Many departments and divisions have an informal mentoring system in place. The following chart outlines the difference between the informal and formal mentoring programs.

Informal Mentoring vs. Formal Mentoring

Informal Mentoring	Formal Mentoring
▪ Goals unspecified ▪ Outcomes unknown ▪ Access limited and may unintentionally exclude ▪ Mentee/mentors self-selected based on chemistry ▪ Mentoring lasts a long time ▪ No or limited training/support ▪ Organization benefits indirectly	▪ Goals established ▪ Outcomes measured ▪ Access open to all who qualify ▪ Mentees/mentors paired based on compatibility ▪ Training and support provided ▪ Mentoring time limited (9-12 months) ▪ Organization benefits directly

Organizational Goals

There are three (3) main organizational goals for this program:



Statement of Purpose

To develop a mentoring program that supports the goal of developing the depth, breadth, and diversity of leadership talent at every level of the organization by:

- Developing relationships that will help the mentee develop the skills, understand and information to further enhance his/her own effectiveness.
- Providing an opportunity for career development and networks within the organization.
- Offering a venue for senior managers to share their learning with less experienced managers.
- Encouraging mentees to take ownership for their personal and professional development.
- Providing mentees with a broader perspective and greater organizational insight.
- Providing mentors with greater organizational insight, understanding of career development challenges at all levels and additional opportunities to hone coaching and feedback skills.

Principles of the Mentoring Program

1. Mentors, chosen from leaders in the organization, act as role models, counselors and coaches in a confidential and non-judgmental manner for the benefit of the mentee.
2. The mentee is responsible for defining the relationship and ensuring clear expectations are set by both individuals.
3. The mentoring relationship is in addition to, rather than instead of, the effective coaching, development and performance enhancement we expect from all managers in the organization.
4. The mentoring relationship is not intended to replace the formal assessment or career development systems in the organization.
5. Mentee and mentor pools are at least one (1) organizational level apart.
