Selected Experience:

DIRECTOR OF VISUAL SERVICES, School of Art, University of Washington, 1995-present

Responsible for management and administration of the Art Slide Library (ASL), Art Media Center (AMC), and classroom audio-visual needs in the Art Building. The ASL contains over 300,000 35mm slides, a small collection of lantern slides, and the MFA thesis statements. More than 85,000 slides are circulated and more than 8,000 slides are added to the collection each year. The ASL is open to all UW faculty, staff, and students. The AMC houses over 35,000 course review slides and an assortment of audio-visual equipment.

Specific responsibilities: hiring, training, and supervision of at least 2.5 FTE staff, plus volunteers and interns; working with the ASL curator and AMC program coordinator to assure smooth operation of both facilities; preparing and monitoring a budget; answering reference questions and assisting collection users; formulating policy and advising on copyright issues; discussing collection development with faculty; overseeing maintenance of a slide cataloging database (130,000+ records) to which more than 9,000 records are added annually, including working with staff to improve the database and set cataloging standards; managing slide circulation with staff assistance; organizing the gathering and recording of collection-related statistics; identifying collection maintenance projects; acting as liaison to Classroom Support Services in regards to maintenance of the four audio-visual classrooms in the Art Building.

Selected accomplishments: improved circulation procedures in 1996; re-organized and documented staff responsibilities, resulting in re-classification of ASL program assistant to curator in 1998; coordinated with School of Art computer specialist to migrate from FoxPro to Filemaker Pro database software in 1998; organized and participated in 1999 inventory of the 35mm slide collections, the first in more than a decade; worked with an MLIS intern in 2000 to create an electronic artist authority database, linked to our slide database, which eventually will replace an existing card file; recruited six additional graduate student interns and volunteers from the Art History program and the School of Library and Information Science to work on special projects during 1999 and 2000; instituted slide replacement fees and invoicing for overdue slides in 2000; successful application for a \$7,500 Frances Blakemore Asian Art Grant; periodic lobbying has developed ongoing supplemental funding for student staff positions; currently starting digitization project of selected images in the ASL.

VICE PRESIDENT/CONFERENCE COORDINATOR, Visual Resources Association (VRA), 1997-1999

Participated fully in all VRA executive board meetings and decisions.

Responsible for overseeing all aspects of planning for international conferences in Philadelphia (1998) and Los Angeles (1999): negotiated hotel contracts; wrote call for participation; proposed and maintained a budget; negotiated conference schedule with VRA executive board; wrote call for papers; coordinated with local arrangements committee on logistics, tours and workshops; prepared master copy for pre-registration packet; communicated and coordinated with moderators; ordered all audio-visual equipment; ordered food for special events and breaks; prepared text for final program; assured the smoothest possible flow of activities at the conferences; and negotiated a hotel contract for the 2000 conference in San Francisco. The Philadelphia and Los Angeles conferences had relatively high attendance (approximately 250 and 275 respectively) and both resulted in profits for VRA.
